**By Mail:** Ballot must be postmarked on or before Tuesday, November 5<sup>th</sup>, 2024 (Election Day) and received in County Election Office by Friday, November 8<sup>th</sup>, 2024 Deadline for receipt of Advance Ballots KSA 25-1132.

**KSA 3304 (a) & (b)**

Deadline for Party affiliation changes (from one recognized party to another/unaffiliated) before November's General Election was at 12:00 p.m., September 3<sup>rd</sup>, 2024. Such declarations cannot be filed from September 3<sup>rd</sup> through October 15<sup>th</sup> (General Election Certification).

An Unaffiliated voter may affiliate by submitting a voter registration application or party affiliation change card any time between now and until/including Election Day.
