COUNTY SOLID WASTE RESOLUTION

AMENDING RESOLUTION NO. 5

A RESOLUTION PROVIDING FOR THE IMPOSITION AND COLLECTION BY THE COUNTY OF FEES FOR THE COLLECTION AND DISPOSAL OF GARBAGE, RUBBISH AND TRASH: AND PRESCRIBING PENALTIES FOR VIOLATION OF ITS PROVISIONS AND REPEALING ALL OTHER ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE COUNTY OF WOODSON:

The following schedule of charges, Part One concerning collection services and Part Two concerning fees for the disposal site, is hereby established as reasonable and in accordance with the volume of refuse handled from the following classifications of residences, dwellings and commercial establishments, to-wit:

PART 1. COLLECTION

- \underline{a} . For each single-family dwelling or each unit of a mutiple-family dwelling containing 3 or less dwelling units--\$8.40 per month for each dwelling unit.
- <u>b.</u> For each commercial establishment, a minimum of \$12.90 per month for once a week pick-up. Additional monthly charges shall be made in accordance with the schedule prepared from time to time by the County Sanitarian and approved by the Governing Body of the County, which schedule shall be based upon the number of pick-ups per month.
- $\underline{c.}$ For multiple-family dwellings containing more than three $\overline{(3)}$ dwelling units, the charge or fee shall be established by the County Sanitarian with the approval of the Governing Body and based upon the volume of refuse or the time expended in collection and disposal thereof in the same manner as for commercial establishments.
- $\underline{\underline{d}}$. For each resident receiving a collection service from bulk containers, a service charge of \$8.00 per month shall apply.
- <u>e.</u> Mobile home courts shall be charged fees to be established in the same manner and at the same rate as commercial establishments; however, where each mobile home is serviced individually, the normal residential charge of \$8.40 per month shall apply.
- \underline{f} . For each commercial establishment, which is occupied by the owner as a residence, a minimum of \$15.40 per month shall apply.
- g. Federal and State bulk container service -- \$22.50 per pickup.

<u>e.</u>	Commercial and/or State, bulk container (Minimum per container)	74.25	per	year
f.	Rural real estate in County	.03	per	acre

SECTION 13. EFFECTIVE DATE. This resolution shall take effect and be in force from and after its publication in the official County newspaper, collection services and fees shall commence August 01, 1993.
