A RESOLUTION ADOPTING THE SOUTHEAST KANSAS SOLID WASTE AUTHORITY SOLID WASTE MANAGEMENT PLAN AND THE WOODSON COUNTY SOLID WASTE MANAGEMENT PLAN AS CONTAINED THEREIN, AND FURTHER CERTIFYING THAT THE GOVERNING BODY OF WOODSON COUNTY, WITH THE ADVICE AND CONSENT OF THE WOODSON COUNTY SOLID WASTE COMMITTEE, HAS REVIEWED SAID SOLID WASTE MANAGEMENT PLANS AND HAS SUBMITTED TO THE SECRETARY OF THE KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT A NOTICE OF REVIEW AND REVISION OF SOLID WASTE MANAGEMENT PLANS, AND FURTHER REQUESTING THAT THE SECRETARY OF THE KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT REVIEW AND APPROVE THE NOTICE OF REVIEW AND REVISION OF SOLID WASTE MANAGEMENT PLANS BY DECEMBER 2, 1997.

WHEREAS, The Governing Body of Woodson County has previously adopted the Southeast Kansas Solid Waste Management Plan and the Woodson County Solid Waste Management Plan as contained therein; and

WHEREAS, The Kansas Department of Health and Environment has approved the Southeast Kansas Solid Waste Management Plan and the Woodson County Solid Waste Management Plan as contained therein on March 28, 1996; and

WHEREAS, The Governing Body of Woodson County has adopted the NOTICE OF REVIEW AND REVISION OF SOLID WASTE MANAGEMENT PLANS on ______, 1997: and

WHEREAS; The Governing Body of Woodson County has entered into an Interlocal Agreement to form and join the Southeast Kansas Solid Waste Operating Authority.

NOW, THEREFORE, BE IT RESOLVED THAT: The Governing Body of Woodson County hereby requests that the Kansas Department of Health and Environment certify the previously approved Southeast Kansas Solid Waste Management Plan and the Woodson County Solid Waste Management Plan as contained therein, including such revisions as have been adopted by the Governing Body in its NOTICE OF REVIEW AND REVISION OF SOLID WASTE MANAGEMENT PLANS as the approved Solid Waste Management Plans of Woodson County and the Southeast Kansas Solid Waste Operating Authority, with such approval to become effective on or before December 2, 1997.

NOTICE OF REVIEW AND REVISION OF SOLID WASTE MANAGEMENT PLANS

The Woodson County Solid Waste Committee has reviewed the Southeast Kansas Solid Waste Management Plan and the Woodson County Solid Waste Management Plan contained therein. The Southeast Kansas Solid Waste Authority's By-Laws did not permit plan implementation. Those By-Laws could only be changed upon unanimous consent of each member county. Montgomery County chose not to approve By-Laws allowing the Southeast Kansas Solid Waste Authority to become an implementing authority. Allen, Bourbon, Cherokee, Crawford, Labette, Neosho, Wilson, and Woodson Counties adopted Interlocal Agreements forming the Southeast Kansas Solid Waste Operating Authority has implementation authority. Allen, Bourbon, Cherokee, Crawford, Labette, Neosho, Wilson, and Woodson Counties have approved resolutions adopting the Southeast Kansas Solid Waste Management Plan and their respective county plans contained therein as their respective official Solid Waste Management Plans and the official Solid Waste Management Plan of the Southeast Kansas Solid Waste Operating Authority, subject to the revisions delineated in this NOTICE OF REVIEW AND REVISION OF SOLID WASTE MANAGEMENT PLANS.
