RESOLUTION NO. 99-06

A RESOLUTION COMMENCING PROCEEDINGS TO DECLARE A CERTAIN PORTION OF 220TH ROAD LYING ONE-HALF MILE EAST AND WEST OF WREN ROAD AS A MINIMUM MAINTENANCE ROAD AND GIVING NOTICE OF A PUBLIC HEARING THEREON.

WHEREAS, the Board of County Commissioners of Woodson County, Kansas is the governing Body of the County, and is charged with the responsibility of determining whether roads within the County should be declared minimum maintenance roads, pursuant to K.S.A. 68-5,102; and

WHEREAS, the Board of County Commissioners of Woodson County, Kansas is of the opinion that a certain portion of 220th Road lying one-half mile east and west of Wren Road all of which is located in Woodson County, Kansas (as described more fully herein), is used only occasionally and is used only by a few individuals; and

WHEREAS, the Board of County Commissioners of Woodson County, Kansas desires to commence proceedings to declare a certain portion of 220th Road lying one-half mile east and west of Wren Road as a minimum maintenance road.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WOODSON COUNTY, KANSAS, AS FOLLOWS:

1. That the Board of County Commissioners of Woodson County, Kansas has determined that the following portion of 220th Road lying one-half mile east and west of Wren Road should be declared a minimum maintenance road as contemplated by K.S.A. 68-5,102:

220th Road lying one-half mile east and west of Wren Road in Woodson County, Kansas, being more particularly described as follows:

Commencing at the Northwest corner of Section 21, Township 23, Range 17 East, thence East on section line (the same being the County line between Woodson and Coffey counties) one mile to the Northeast corner of Section 21, Township 23, Range 17 East, aforesaid Road 50 feet wide except from Northwest corner of NE1/4 of Section 21, thence East two (2) chains, which is 80 feet (40 feet on each side of section line).

- 2. That a public hearing shall be scheduled for the purpose of determining whether the above described road should be declared a minimum maintenance road. Said hearing shall be held in the Commissioners' Room of the Woodson County Courthouse, 105 W. Rutledge, Yates Center, Kansas on August 3, 1999 at 10:00 a.m.
- 3. That any person wishing to appear at the aforementioned hearing and give evidence or testimony thereon may do so.

- 4. That at the conclusion of the aforementioned hearing, the Board of County Commissioners, Woodson County, Kansas shall determine what road or part of the road described herein is to be declared a minimum maintenance road.
 - 5. That this Resolution shall be published once in the official County newspaper.
